<b>Explanation of Rule(s)</b>	<p><b>Personal residence - Real property.</b> Regarding reporting the information otherwise required by RCW <a href="#">42.17A.710</a> (1)(h) through (k):</p> <p>(i) Under WAC <a href="#">390-24-200</a>, the filer shall list the street address of each parcel, the assessor's parcel number, the abbreviated legal description appearing on property tax statements, or the complete legal description. Each property description shall be followed by the name of the county in which the property is located.</p> <p>(ii) No modification will be necessary if the filer describes the real property using one of the alternatives in WAC <a href="#">390-24-200</a>, plus the name of the county.</p> <p>(iii) A modification will be required if the filer seeks some other means to describe reportable real property including the personal residence of the filer. The commission may consider a modification, for example, when the filer or his or her immediate family member has received a threat, has a no contact order, or presents a similar personal safety concern.</p> <p>A prospective modification to allow nondisclosure of a residential address may be granted if the applicant or an immediate family member has received a threat, been issued a no contact order or presents a similar personal safety concern.</p> <p><b>Other.</b> An applicant may be exempted from reporting information otherwise required under RCW <a href="#">42.17A.710</a> which would constitute a</p>

	manifestly unreasonable hardship in a particular case, when the circumstances presented would not indicate any actual or potential conflict with the proper performance of the duties of the office sought or held.

<b>Reason(s) for Modification (as stated by filer)</b>	<ul style="list-style-type: none"> <li>Ms. Feagan is requesting a reporting modification that would exempt her from reporting real estate, including street address, parcel number, or legal description, for her residential address, and for a second investment property with private renters, on her Personal Financial Affairs Statement covering twelve calendar months prior to becoming a candidate.</li> <li>Ms. Feagan stated that she is requesting a modification based upon news coverage about the incumbent candidate concerning intimidation and suggested violence, with the incumbent candidate taking photographs outside the home of a previous opponent.</li> </ul>
<b>Other Issues</b>	<p>Ms. Feagan disclosed creditor information, payment terms, security given and mortgage amounts for the personal residence and investment property, on the report covered by this modification request.</p> <p>Ms. Feagan's residential address is also associated with 79 individual contribution records reported by other candidates and political committees, available to the public on the PDC's website.</p>
