Citizens for Kim Wyman
Executive Summary and Staff Analysis
PDC Case 5925

This Executive Summary highlights staff's findings, conclusions, and recommendations regarding a 45-Day Citizen Action Complaint (Complaint) against Kim Wyman, incumbent Washington State Secretary of State and a candidate seeking re-election to that office in 2016. The complaint was filed with the Public Disclosure Commission (PDC) by Jaxon Ravens, Chair of the Washington State Democratic Party.

Allegations

The Complaint alleged that the 2016 Citizens for Kim Wyman campaign (Campaign) violated RCW 42.17A.235 and .240 by failing to timely file Monetary Contribution reports (C-3 reports) and Campaign Summary Contribution and Expenditure reports (C-4 reports) for campaign activities undertaken in April of 2016.

Background

On January 18, 2013, Kim Wyman filed a Candidate Registration (C-1 report) declaring her candidacy for re-election to the office of Washington Secretary of State and opening her campaign.

The Campaign received a formal written warning from the PDC earlier this year based on a complaint that the Wyman campaign violated RCW 42.17A.560 by scheduling a campaign fundraising event during the 2016 Legislative session freeze period. **Exhibit #1.**

Investigative Findings

Staff conducted a review of the C-3 and C-4 reports filed by the Citizens for Kim Wyman Campaign for the entire 2016 election, and found the following:

1. April of 2016:

Timely Reports: On May 9, 2016, the Campaign timely filed: Two C-3 reports totaling \$3,420 in contributions received in April 2016; and one C-4 report disclosing the receipt of \$3,420 in monetary contributions, \$234 for in-kind contributions, and \$17,924 in expenditures made, with a cash on hand balance of \$44,943.

Untimely Reports: On May 20, 2016, the Campaign filed 11 new C-3 reports disclosing an additional \$30,567.50 in monetary contributions received and deposited during the month of April 2016. The C-3 reports were filed 10 days late disclosing the contributor information. On that same day, the Campaign filed an amended C-4 report disclosing the receipt of \$30,568 in new monetary contributions, the previously reported \$234 for in-kind contributions, and \$18,867 in total expenditures made that included \$943 in new expenditures from the original C-4 filing. The \$943 in new expenditures included \$722

for printing and postage, \$112 for credit card processing fees and business checking fees, and \$49 for Facebook advertisements, which were disclosed 10 days late.

On May 22, 2016, Secretary Wyman submitted a letter to the PDC, self-reporting the late filed C-3 and C-4 reports. **Exhibit #2.**

In addition to the late filed reports, staff found the Campaign received two \$100 monetary contributions on April 25, 2016, that were deposited into the campaign bank account on May 5, 2016, which was three days late.

2. Calendar Years 2013 to 2015:

Staff's review of the C-3 and C-4 reports filed by the Campaign for calendar years 2013 through 2015 found the following: (1) The Campaign filed four C-3 reports totaling \$5,375 that were 29-55 days late; (2) the Campaign filed three C-3 reports totaling \$3,100 that were six to 29 days late, with six of the contributions on the C-3 reports appearing to have been deposited three to 27 days late; (3) the Campaign timely filed five C-3 reports totaling \$6,850 that disclosed contributions that appear to have been deposited two to nine days late; and (4) the Campaign failed to timely file seven C-4 reports (filed between three and 25 days, and the expenditure information listed on four of the C-4 reports was disclosed 29 to 274 days late).

Conclusion:

While Ms. Wyman "self-reported" that her Campaign late-filed the April 2016 contribution and expenditure reports, and offered mitigating factors for those reports, the Campaign failed to timely file required contribution and expenditure reports for April 2016. In addition, the Campaign failed to timely file C-3 and C-4 reports during calendar years 2013 to 2015; and failed to timely deposit some monetary contributions received.


Thank you for taking corrective action and bringing your campaign into compliance with PDC laws and rules by cancelling the fundraising events and removing the solicitations from your website.

Enclosed is a copy of a letter sent to Kim Wyman concerning your complaint filed with the Public Disclosure Commission (PDC) on February 22, 2016. The complaint alleged that the Wyman campaign violated RCW 42.17A.560 by scheduling campaign events during the 2016 legislative session.

PDC staff reviewed your allegations and found the following:


- The Wyman campaign did schedule and advertise fundraising events during the legislative session in violation of RCW 42.17A.560.
- When made aware of the complaint, the Wyman campaign removed all advertising for the events and cancelled them – bringing their activity into compliance with PDC laws and rules.
- Kim Wyman has no previous violations of PDC laws and rules.

Based on these initial findings, we are issuing a Formal Written Warning to Kim Wyman in accordance with WAC 390-37-060(1)(b). If there are future violations of PDC laws or rules, the Commission will consider this Formal Written Warning in deciding on further Commission action.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint.

Dear Ms. Fielding Lopez,

I am writing to inform you and the Public Disclosure Commission of a decision I made for my campaign, Citizens for Kim Wyman, regarding our April financial filings.

Our campaign has a team of two volunteers who process and handle our treasurer duties. One is responsible for PDC compliance and filings, Ron Hoene, and a second, Debbie Swift, who handles our banking deposits. Ms. Swift had a major medical procedure completed in January that caused her to be in Family Medical Leave Act status for several months at her full time job. This condition, which occurred during the fundraising freeze, rendered her unable to perform her duties as campaign treasurer.

She returned to work on the campaign in mid to late April. By early May it became clear that as she was recovering from her procedure, we had fallen behind in our data collection for contributions for our April reporting.

At the end of April, in time for the May 10 filing, we filed all of the contributions we had with complete information to the PDC. However, due to the delays in data collection and input into our campaign tracking system, combined with the timing of the majority of our donations arriving in late April, we had missing occupation information for many donors. We reported the remaining April contributions, without all of the donor occupations listed, on May 20, 2016. We plan to report the remaining occupation information as soon as we completely compile the data.

Our contributions and expenditures for April have been reported and it is my belief we are in compliance for our reporting. I wanted to make you aware of our decision of how we chose to report the information. Please let me know if we need to do anything further.

Report of Investigation

I. Background and Allegations

- 1.1 On January 18, 2013, Kim Wyman filed a Candidate Registration (C-1 report) declaring her candidacy for re-election to the office of Washington Secretary of State, selecting the Full Reporting option and listing Ron Hoene as the Campaign Treasurer. **Exhibit #1.**
- 1.2 Ms. Wyman was elected Washington Secretary of State in 2012. Prior to that, she was appointed Thurston County Auditor in January of 2001 and elected to that position later that year, and re-elected Auditor in 2002, 2006 and 2010.
- 1.3 On June 2, 2016, a 45-Day Citizen Action Letter (Complaint) was filed with the Washington State Attorney General's Office (AG's Office) by Jaxon Ravens, Chair, Washington State Democratic Party. The Complaint alleged that the 2016 Citizens for Kim Wyman campaign violated RCW 42.17A.235 and .240 by failing to timely file Monetary Contribution reports (C-3 reports) and Campaign Summary Contribution and Expenditure reports (C-4 reports). **Exhibit #2.**
- 1.4 On June 14, 2016, the AG's Office sent a letter to Evelyn Fielding Lopez, PDC Executive Director, referring the June 2, 2016 Complaint filed against Kim Wyman to the PDC, and requesting that PDC staff review and investigate the allegations.

II. Findings

- 2.1 Candidates seeking election to office in 2016 that filed C-1 reports in a previous calendar year and selected the Full Reporting option were required to file monthly C-3 and C-4 reports. The C-3 and C-4 reports are due to be filed not later than the 10th of each month disclosing contribution and expenditure activities that occurred in the previous calendar month. On June 1, 2016, the C-3 and C-4 reporting requirements become more frequent as the candidate gets closer to the 2016 primary and general election dates.
- 2.2 On May 9, 2016, Citizens for Kim Wyman (Campaign) timely filed two C-3 reports totaling \$3,420 disclosing the following: (1) \$2,520 in monetary contributions had been received on April 13, 2016, and deposited on April 14, 2016; and (2) \$900 in monetary contributions had been received during the period of April 11 through 16, 2016, and deposited on April 21, 2016.
- 2.3 On May 20, 2016, the Campaign filed 11 new C-3 reports disclosing that \$30,567.50 in monetary contributions had been received and deposited during the month of April 2016, and disclosed 10 days late as detailed in the chart below. **Exhibit #3.**

- 2.4 On May 9, 2016, the Campaign timely filed the April 2016 C-4 report disclosing the receipt of \$3,420 in monetary contributions, \$234 for in-kind contributions, and \$17,924 in expenditures made, with a cash on hand balance of \$44,943. **Exhibit #4.**

- 2.5 On May 20, 2016, the Campaign filed an amended April 2016 C-4 report disclosing the receipt of an additional \$30,568 in new monetary contributions received (\$33,988 in total monetary contributions), \$234 for in-kind contributions, and \$18,867 in total expenditures made, that included an additional \$943 in new expenditures from the original C-4 filing. **Exhibit #5.** The C-4 report disclosed that the Campaign had a revised cash on hand balance of \$74,568, and the \$943 in new expenditures included \$722 for printing and postage, \$112 credit card processing fees and business check fees, and \$49 for Facebook advertisements.
- 2.6 RCW 42.17A.220 requires all monetary contributions received by a candidate to be deposited into the bank account within five business days of receipt. Staff reviewed the C-3 and C-4 reports filed by the Campaign for April 2016, and discovered two \$100 monetary contributions appear to have been received and deposited in April of 2016, but held longer than five business days before being deposited. The two contributions totaled \$200, were received on April 25, 2016, deposited on May 5, 2016, and disclosed on a C-3 report filed on June 2, 2016. The C-3 report disclosed \$7,471 in monetary contributions received, so \$7,271 of the contributions were timely deposited.

Kim Wyman Responses

- 2.7 On May 22, 2016, Kim Wyman submitted a letter to the PDC, two days after filing the new C-3 reports and an amended C-4 report, but prior to the Complaint, self-reporting the late filed Campaign reports and explaining the mitigating factors that led to the oversight. **Exhibit #6.** Ms. Wyman stated that her 2016 campaign team included two volunteers: Ron Hoene, who is responsible for PDC Compliance and filing PDC reports, and Debbie Swift, who handles the monetary contributions received and Campaign bank deposits.
- 2.8 Ms. Wyman stated that Ms. Swift had a “major medical procedure” in January of 2016, which caused her to miss several months from her full time job, and assisting with the Campaign. Ms. Swift returned to work and resumed her volunteer work for the Campaign in mid to late April of 2016. Ms. Wyman stated that: “By early May it became clear that as she was recovering from her procedure, we had fallen behind in our data collection for contributions for our April reporting.”
- 2.9 On June 24, 2016, Dan Brady, an attorney representing the Campaign, submitted a letter to the PDC in response to the Complaint filed by Mr. Ravens. **Exhibit #7.** The letter stated that on May 16, 2016, Ms. Wyman reviewed the April 2016 C-3 reports filed by her Campaign and discovered that the number of contributions and contributors appeared much lower than had actually been received in April. She stated that she contacted both Ms. Swift and Mr. Hoene inquiring about the lower than expected contribution totals.

2.10 It was at that time Ms. Wyman became aware that Ms. Swift was not able to collect all of the required contributor information after returning to her Campaign bookkeeping role after the “serious medical issue.” Ms. Wyman “...directed Ms. Swift to report all available and yet unreported donor information to Mr. Hoene immediately...” which she completed by May 19th. The Campaign filed the remaining C-3 reports for contributions received during the month of April 2016 the next day, on May 20, 2016. Mr. Brady stated the following:

- “On Sunday, May 22, 2016, Sec. Wyman personally informed PDC Executive Director Evelyn Fielding Lopez via email and an attached letter of the facts and circumstances...” concerning the recently filed new C-3 reports for April of 2016.
- During the review process, Ms. Swift found a few Campaign expenditures totaling less than \$1,000 that had been made in April of 2016, but not disclosed on the April 2016 C-4 report. On May 20, 2016, Mr. Hoene also filed an April 2016 amended C-4 report disclosing those expenditures.
- Mr. Brady stated that the late reported expenditures were “...small, involved no substantial advertising, and occurred more than five months before the general election...In the end, a number of contributors and the amounts of their contributions were delayed by ten days.”
- Mr. Ravens filed the Complaint on June 2, 2016, in which he “...offered no discernable impact of this delay on the candidates or campaigns involved or the election for this office...” In addition, Mr. Ravens made no argument that the delayed disclosure of the contribution and expenditure information “...impacted the campaigns in any manner.”
- Ms. Wyman was “...the only candidate disadvantaged by the delayed disclosure (since she) ... was unable to demonstrate to the public the additional support...” that her Campaign received in April 2016 concerning the \$30,568 in monetary contributions received and deposited.

Prior PDC Enforcement/Warning letter

2.11 On February 22, 2016, Amy Bowhay filed a complaint with the PDC alleging that the Campaign violated RCW 42.17A.560 by scheduling a campaign fundraising event during the 2016 Legislative session freeze period. RCW 42.17A.560 prohibits legislators and state officials from soliciting or accepting contributions beginning 30 days prior to the January Legislative session convening, through the entire session until it is formally adjourned.

- 2.12 On March 28, 2016, PDC staff sent a complaint return letter to Ms. Bowhay, along with a copy of a warning letter to Ms. Wyman. **Exhibit #8.** The letter to Ms. Wyman confirmed the campaign had taken corrective action to comply with PDC laws and rules concerning soliciting and accepting contributions during a legislative session freeze period by cancelling the upcoming fundraising events and removing the solicitations page from her Campaign website.
- 2.13 The letter informed Ms. Wyman that in accordance with WAC 390-37-060(1)(b), she was being issued a Formal Written Warning for solicitation of campaign contributions during the 2016 legislative session freeze period. The letter went on to state that "...If there are future violations of PDC laws or rules, the Commission will consider this Formal Written Warning in deciding on further Commission action."

Staff review of C-3 and C-4 report filed by the Campaign for calendar years 2013-2015

- 2.14 Prior to completing the investigation into the allegations listed in the Complaint, PDC staff conducted a limited review of the C-3 and C-4 reports filed by the Campaign for the entire 2016 election cycle. Based on that review and a staff generated Word document, it appears the Campaign failed to timely file C-3 reports and C-4 reports. In addition, based solely on the deposit dates listed on the C-3 report and at the top section of the Schedule A to C-4 reports, it also appears the Campaign failed to timely make bank deposits for monetary contributions received within five business days of receipt. **Exhibit #9.**
- 2.15 Staff's review of the C-3 and C-4 reports filed by the Campaign for calendar years 2013 through 2015 found the following:
- The Campaign filed four C-3 reports totaling \$5,375 that were filed 29-55 days late.
 - The Campaign filed three C-3 reports totaling \$3,100 that were filed six to 29 days late, with six of those contributions appearing to have been deposited three to 27 days late.
 - The Campaign timely filed five C-3 reports totaling \$6,850 that included contributions received which appear to have been deposited two to nine days late.
 - The Campaign failed to timely file seven C-4 reports. The C-4 reports were filed between three and 25 days, and the expenditure information listed on four of the C-4 reports was disclosed 29 to 274 days late.

III. Scope

3.1 PDC staff reviewed the following documents:

- The Citizen Action Letter filed with the Attorney General's Office by Jaxen Ravens against the Kim Wyman Campaign on June 2, 2016.
- C-1 reports, C-3 reports, and C-4 reports filed by the 2016 Citizens for Kim Wyman Campaign.
- Results of queries of the PDC contribution and expenditure databases.
- May 22, 2016, e-mail with attached letter from Kim Wyman to Evelyn Fielding Lopez, PDC Executive Director.
- June 24, 2016, e-mail with attached letter from Dan Brady, attorney representing the Citizens for Kim Wyman, to PDC staff responding to the allegations in the Complaint.

IV. Laws

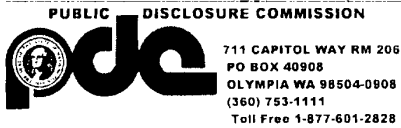
- 4.1 **RCW 42.17A.235** and **240** require continuing political committees to file timely, accurate reports of contributions and expenditures. Under the full reporting option, until five months before the general election, C-4 reports are required monthly when contributions or expenditures exceed \$200 since the last report.
- 4.2 **RCW 42.17A.220** states in part the following: "All monetary contributions received by a candidate or political committee shall be deposited by the treasurer or deputy treasurer in a depository in an account established and designated for that purpose. Such deposits shall be made within five business days of receipt of the contribution."



Dear Attorney General Ferguson:

The Washington State Democratic Party (the "Party") reports two apparent violations of Washington's campaign disclosure and contribution laws by Secretary of State Kim Wyman's ("Secretary Wyman") campaign. Specifically, Secretary Wyman's campaign failed to timely report tens of thousands of dollars in expenditures and contributions made and received in April 2016. This latest incident appears to be the latest in a pattern of campaign finance violations by Secretary Wyman's campaign.

I. Campaign Disclosure Requirements

During May 2016, Secretary Wyman appears to have violated RCW 42.17A.235 and RCW 42.17A.240 by failing to report more than \$30,000 in campaign contributions and almost \$1,000 in campaign expenditures by the statutory monthly-filing deadline.

Candidates must file reports with the Public Disclosure Commission ("PDC") containing the mandatory campaign contribution and expenditure information required by RCW 42.17A.240. Secretary Wyman was required to report contributions received and expenditures made in April

2016 by May 10, 2016. RCW 42.17A.235(2)(c). PDC Form C3 is the mandatory form for disclosing bank deposits of campaign contributions. WAC 390-16-031. PDC Form C4 is the mandatory form for disclosing monthly summaries of total campaign contributions and expenditures. WAC 390-16-041. These requirements are not applicable if the candidate did not receive a contribution or make an expenditure in the preceding calendar month exceeding two hundred dollars since the candidate's last report. RCW 42.17A.235(2)(c).

II. Possible Violations of Statutory Campaign Disclosure Requirements

On May 9, 2016, one day before the May 10 deadline for disclosing contributions and expenditures for the month of April 2016, Secretary Wyman's campaign filed two C3 reports. Exhibit 1. The two reports disclosed 22 total campaign contributions totaling \$3,420. *Id.* The same day, her campaign filed its mandatory monthly C4 report disclosing \$3,420 in total campaign contributions for April. Exhibit 2.

On May 20, 2016, 10 days after the statutory deadline, Secretary Wyman's campaign filed 11 additional C3 reports for the month of April detailing 248 separate contributions totaling \$30,567.50 for the month of April. Exhibit 3. The same day, her campaign filed an amended C4 report showing \$33,987.50 in total campaign contributions for April. Exhibit 4. As a result, it appears that Secretary Wyman's campaign violated the campaign contribution disclosure requirements of RCW 42.17A.235(2)(c) by grossly underreporting its income for the month of April when it filed its original disclosures.

Finally, it also appears that Secretary Wyman's campaign failed to comply with applicable disclosure laws for campaign *expenditures* as well. In addition to underreporting its campaign contributions for the month of April, the C4 report filed on May 9 also failed to report six campaign expenditures for the month of April, totaling \$942.89, and in apparent violation of RCW 42A.17.240(6). Exhibit 2.

III. Requested Relief

Washington's campaign finance laws are designed to ensure that voters have the information they need to "follow the money." Full, accurate, and timely reporting of campaign contributions and expenditures lies at the core of Washington's campaign finance regime.

Here, Secretary Wyman appears to have failed to comply with these basic reporting requirements by failing to timely and fully disclose tens of thousands of dollars of contributions and expenditures from April 2016. This would not be Secretary Wyman's first violation of Washington's campaign disclosure and contribution laws. Just two months ago, the Public Disclosure Commission served Secretary Wyman with a Formal Written Warning for inappropriately soliciting campaign contributions during the 2016 legislative session freeze period. *See* Exhibit 5. This formal warning explicitly cautions Secretary Wyman that "[i]f there are future violations of PDC laws or rules, the Commission will consider this Formal Written Warning in deciding on further Commission action."

This pattern of repeated noncompliance with campaign finance reporting requirements demonstrated by Secretary Wyman's campaign is deeply troubling and appears to reflect either (a) a larger problem with accountability and oversight in Secretary Wyman's campaign, (b) blatant disregard of public disclosure requirements, or (c) both. The Party respectfully requests that you conduct a formal investigation into the nature and extent of these potential violations.



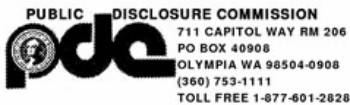


Thank you for taking corrective action and bringing your campaign into compliance with PDC laws and rules by cancelling the fundraising events and removing the solicitations from your website.

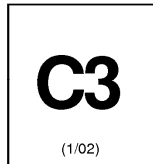

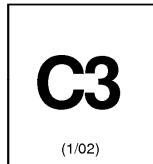

I am writing to inform you and the Public Disclosure Commission of a decision I made for my campaign, Citizens for Kim Wyman, regarding our April financial filings.

Our campaign has a team of two volunteers who process and handle our treasurer duties. One is responsible for PDC compliance and filings, Ron Hoene, and a second, Debbie Swift, who handles our banking deposits. Ms. Swift had a major medical procedure completed in January that caused her to be in Family Medical Leave Act status for several months at her full time job. This condition, which occurred during the fundraising freeze, rendered her unable to perform her duties as campaign treasurer.

She returned to work on the campaign in mid to late April. By early May it became clear that as she was recovering from her procedure, we had fallen behind in our data collection for contributions for our April reporting.

At the end of April, in time for the May 10 filing, we filed all of the contributions we had with complete information to the PDC. However, due to the delays in data collection and input into our campaign tracking system, combined with the timing of the majority of our donations arriving in late April, we had missing occupation information for many donors. We reported the remaining April contributions, without all of the donor occupations listed, on May 20, 2016. We plan to report the remaining occupation information as soon as we completely compile the data.

Our contributions and expenditures for April have been reported and it is my belief we are in compliance for our reporting. I wanted to make you aware of our decision of how we chose to report the information. Please let me know if we need to do anything further.

In a letter dated June 15, 2016, you informed Sec. Wyman that a formal investigation into her campaign, Citizens for Wyman (the Campaign), had been opened in response to a 45-day Citizen Action Letter and complaint filed by Jaxon Ravens, Chair of the Washington State Democratic Central Committee, on June 2, 2016. In that letter you requested a response no later than June 23, 2016. I am representing Secretary Wyman's campaign in this matter which has been assigned Case No. 5925.

Background

On May 16, 2016, Sec. Wyman reviewed her Campaign's C-3 filing of May 10, 2016 covering the month of April. At that time, Sec. Wyman recognized that the number of contributions and contributors appeared far too low for that month. Sec. Wyman contacted her volunteer bookkeeper, Debbie Swift, and her volunteer PDC compliance assistant, Ron Hoene, to inquire about the lower than expected numbers. During those conversations she learned that Ms. Swift had been unable to collect and process all the contributor information in a timely fashion after returning to her bookkeeping role after an absence due to a very serious medical issue, and that, in turn, that information was not forwarded to Mr. Hoene.

That same day, May 16, 2016, Sec. Wyman directed Ms. Swift to report all available and as yet unreported donor information to Mr. Hoene immediately. That process was completed on May 19, 2016, and a new C-3 covering the month of April was filed on Friday, May 20, 2016. On Sunday, May 22, 2016, Sec. Wyman personally informed PDC Executive Director Evelyn Fielding Lopez via email and an attached letter of the facts and circumstances regarding the new C-3 for the month of April. Attachments 1 and 2. On May 23, 2016, PDC Filer Assistance Specialist Jennifer Hansen confirmed receipt of Sec. Wyman's email and indicated that she would add the explanation to Citizens for Wyman's PDC filings. Attachment 3.

Also during this review process, Ms. Swift found a few expenses totaling less than \$1,000 that had been left off the C-4 filed May 10, 2016 – again due to her catching up with bookkeeping after

her medical absence. Ms. Swift dutifully reported these expenses to Mr. Hoene who then filed an amended C-4 on May 20, 2016. On June 2, 2016, Mr. Ravens filed his complaint.

Analysis

In the end, a number of contributors and the amounts of their contributions were delayed by ten days. Fortunately the delay was short and occurred more than five months from the general election. In his complaint, Mr. Ravens' offered no discernable impact of this delay on the candidates or campaigns involved or the election for this office. In fact, the only candidate was disadvantaged by the delayed disclosure was Sec. Wyman who was unable to demonstrate to the public the additional support she had on May 10, 2016.

As for the expenditures, the amount involved is relatively small, involved no substantial advertising, and occurred more than five months before the general election. Amendments of this nature are not uncommon, and no argument has been made by Mr. Ravens why delayed disclosure here impacted the campaigns in any manner.

Finally, while the delayed disclosures were solely due to Ms. Swift's absence due to illness, Sec. Wyman still believes there should never be substantially delayed disclosure of campaign contributor or expenditure information. Ms. Wyman now will have all management staff review each disclosure form well before filing to ensure completeness.

Conclusion

Sec. Wyman takes public disclosure requirements very seriously and when a lapse in the internal compliance process was found, again due to the extenuating circumstances of Ms. Swift's illness, she handled it exactly the right way: Directing staff to process and file all contributor data on hand and informing the PDC Executive Director immediately of the problem as well as her solution. In fact, the only reason Mr. Ravens was able to bring a complaint at all in this case was because Sec. Wyman corrected the delay and disclosed the matter to the highest authority at the PDC.


Thank you for taking corrective action and bringing your campaign into compliance with PDC laws and rules by cancelling the fundraising events and removing the solicitations from your website.

PDC staff reviewed your allegations and found the following:


- The Wyman campaign did schedule and advertise fundraising events during the legislative session in violation of RCW 42.17A.560.
- When made aware of the complaint, the Wyman campaign removed all advertising for the events and cancelled them – bringing their activity into compliance with PDC laws and rules.
- Kim Wyman has no previous violations of PDC laws and rules.

Based on these initial findings, we are issuing a Formal Written Warning to Kim Wyman in accordance with WAC 390-37-060(1)(b). If there are future violations of PDC laws or rules, the Commission will consider this Formal Written Warning in deciding on further Commission action.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint.

Late filed C-3 reports: Four C-3 reports totaling \$5,375 were filed 29-55 days late.

- On December 4, 2013, the Campaign filed a C-3 report disclosing a \$500 contribution had been received on September 3, 2013, and deposited on September 10, 2013. The C-3 report was filed 55 days late.
- On December 9, 2013, the Campaign filed a C-3 report disclosing 16 contributions totaling \$3,775 that had been received on October 10, 2013, and deposited on October 15, 2013. The C-3 report was filed 29 days late.
- On December 9, 2013, the Campaign filed a C-3 report disclosing a \$1,000 contribution had been received on October 9, 2013, and deposited on October 17, 2013. The C-3 report was filed 29 days late.
- On December 9, 2013, the Campaign filed a C-3 report disclosing a \$100 contribution had been received on September 27, 2013, and deposited on October 3, 2013. The C-3 report was filed 29 days late.

Late filed C-3 reports and deposit of contribution: Three C-3 reports totaling \$3,100 were filed six to 29 days late, and six of the contributions received were deposited three to 27 days late.

- On December 9, 2013, the Campaign filed a C-3 report disclosing three contributions totaling \$1,550 had been received on October 10, 22, and November 1, 2013, and all three deposited on November 12, 2013. The two October 2013 contributions totaling \$1,300 were disclosed 29 days late, and the three contributions were deposited four to 27 days late.
- On December 11, 2013, the Campaign filed a C-3 report disclosing a \$200 contribution had been received on October 16, 2013, and deposited on December 11, 2013. The C-3 report was filed 29 days late and the contribution was deposited 19 days late.
- On December 16, 2014, the Campaign filed a C-3 report disclosing two contributions totaling \$1,350, one received on November 17 and the other received December 2, 2014, with both deposited on December 12, 2014. The C-3 report was filed six days late and the contributions were deposited three to 19 days late.

Late deposit of campaign contributions: Five C-3 reports totaling \$6,850 included contributions received that were deposited two to nine days late.

- On June 3, 2015, the Campaign timely filed a four-page C-3 report disclosing numerous contributions totaling \$4,475 that had been received April 26 to 28, 2015, and deposited on May 7, 2013. The contributions were deposited two to four days late.

- On October 8, 2015, the Campaign timely filed a C-3 report disclosing the receipt of two monetary contributions on September 1, 2015 totaling \$700, that had been deposited on September 17, 2015. The two contributions were deposited nine days late.
- On October 8, 2015, the Campaign timely filed a C-3 report disclosing the receipt of a \$1,500 monetary contribution on September 1, 2015 from an individual, that had been deposited on September 15, 2015. The contribution was deposited seven days late.
- On December 10, 2015, the Campaign timely filed two C-3 reports totaling \$175 in contributions received, that were deposited two to three days late.

Late filed C-4 reports:

- On December 9, 2013, the Campaign filed a C-4 report covering the period of January 21 through November 30, 2013, disclosing the receipt of \$11,625 in monetary contributions and made expenditures totaling \$1,453. Based on the PDC laws, rules and reporting requirements, the information disclosed on the C-4 report indicated the Campaign should have filed the following C-4 reports:
 1. February 2013 C-4 report: Disclosing a \$241 expenditure made by the Campaign on February 11, 2013 to the Sheraton Hotel for hotel accommodations. The expenditure was disclosed 274 days late.
 2. April 2013 C-4 report: Disclosing three expenditures made by the Campaign totaling \$314.19 on April 8, 15 and 16, 2013. The three expenditures were disclosed 243 days late.
 3. September 2013 C-4 report: Disclosing a \$500 bank deposit made on September 10, 2013, and three expenditures totaling \$114.24 that were made in May and June. The contribution and expenditure information was disclosed 60 days late.
 4. October 2013 C-4 report: Disclosing a \$3,775 bank deposit made on October 15, 2013, and three expenditures totaling \$41.65 that were made in October. The contribution and expenditure information was disclosed 29 days late.
- On May 5, 2014, the Campaign filed a C-4 report covering the period of February 1 through April 30, 2014, disclosing no contributions had been received and \$1,034 in expenditures made. The information disclosed on the C-4 report indicates the Campaign made three expenditures in March of 2014 totaling \$590.18 that should have disclosed on April 10, 2014. The information was disclosed 25 days late.
