### Washington Against Discrimination Everywhere (WADE) PDC Case 121957

WADE, a Statewide Ballot Measure political action committee registered with the PDC on June 18, 2020, and its principal committee member, Jesse Wineberry, is alleged to have violated RCW 42.17A.235(9) and .240 by filing an inaccurate Final Summary Full Campaign Contribution and Expenditure (C-4) report and RCW 42.17A.205(4) by failing to update the Committee Registration (C-1pc).

### Buckley, Edwin PDC Case 144799

PDC staff alleges Edwin Buckley, a candidate for Lakewood Water and Sewer District, Pos. 3 in the 2023 election, violated RCW 42.17A.235 and .240 by failing to timely and accurately file Monetary Contribution reports (C-3 reports) and Summary Full Campaign Contribution and Expenditure reports (C-4 reports), disclosing contributions and expenditures undertaken by the Campaign as required by campaigns registered under the "Full Reporting" option.
