An applicant may be exempted from reporting the information otherwise required by RCW 42.17A.710 for members of the applicant's immediate family, if:</p> <p>(i) Such information relates to a financial interest held by such member under a bona fide separate property agreement, or other bona fide separate status; and, such financial interest is not a present or prospective source of income to the applicant or to any other person who is dependent upon the applicant for support in whole or in part; or</p> <p>(ii) Reporting the name of an entity in which the immediate family holds an interest of ten percent or more would be likely to adversely affect the competitive position of the entity, under RCW 42.17A.120.</p>

Reason(s) for Modification (as stated by filer)	<ul style="list-style-type: none">• Lorin Lathrop is requesting a renewal of a previously granted partial reporting modification that would exempt him from disclosing a ROTH IRA in his spouse's name only and not a joint asset.• Mr. Lathrop states that school board directors are unpaid, and his wife's ROTH IRA has no benefit by his service on the board.• Mr. Lathrop states that his wife has an independent ROTH IRA that is in her name. He attests that he does not have access to the account and does not have specific knowledge of the balance. Further, his wife is unwilling to share the information about this retirement account.• Mr. Lathrop has confirmed that he has reported his personal retirement accounts, their mutually owned real estate, debts and their children's 529 college accounts, as required.
Other Issues	<ul style="list-style-type: none">• Lorin Lathrop has reviewed his initial reporting modification request, the Commission's Order granting this request, and has certified that there are no changes to the facts related to his request.• Mr. Lathrop has agreed to recuse himself if a matter came before him involving a conflict of interest between interest between his personal interests and public duties of his appointed position.• Mr. Lathrop's request could be granted for the remainder of his elected term of office in accordance with RCW 42.17A.120(1).
