| <b>Explanation of Rule(s)</b>        | <p><b>Personal residence - Real property.</b> Regarding reporting the information otherwise required by RCW <a href="#">42.17A.710</a> (1)(h) through (k):</p> <p>(i) Under WAC <a href="#">390-24-200</a>, the filer must list the street address of each parcel, the assessor's parcel number, the abbreviated legal description appearing on property tax statements, or the complete legal description. Each property description must be followed by the name of the county in which the property is located.</p> <p>(ii) No modification will be necessary if the filer describes the real property using one of the alternatives in WAC <a href="#">390-24-200</a>, plus the name of the county. Judges, prosecutors, or sheriffs may describe a personal residence in the alternative manner provided under RCW <a href="#">42.17A.710</a>(2), and WAC <a href="#">390-24-200</a> without a modification.</p> <p>(iii) A modification will be required if the filer seeks some other means to describe reportable real property including the personal residence of the filer. The commission may consider and grant such a modification to amend the description of a residential address to the extent necessary to protect the applicant or an immediate family member who has received a threat, has obtained a no contact order, or has presented a similar personal safety concern.</p> <p><b>Other.</b> An applicant may be exempted from reporting information otherwise required under RCW <a href="#">42.17A.710</a> which would constitute a manifestly unreasonable hardship in a particular case, when the circumstances presented would not indicate any actual or potential conflict with the proper performance of the duties of the office sought or held.</p> |

| <b>Other Issues</b>                                       | <ul style="list-style-type: none"><li>• Mr. Wright has agreed to recuse himself if there is a conflict of interest between his duties as an annual filer and his personal interests.</li><li>• PDC staff have informed Mr. Wright of the residential address alternatives set forth in <a href="#">WAC 390-24-200</a> for his future filings.</li><li>• Mr. Wright's records would be exempt from public disclosure if the Commission finds in accordance with <a href="#">RCW 42.17A.120</a> and <a href="#">WAC 390-28-080</a> that disclosure of such information would present a personal risk to a reasonable person.</li></ul> |
