Today's Brief Adjudicative Proceeding (BAP) concerns 2023 candidates who won their election whom PDC staff allege have violated RCW 42.17A.235 and .240 by failing to file or timely file a required Receipts & Expenditure Summary (C-4 report) that was due to be filed with the PDC during the 2024 election cycle.
