PDC staff alleges Randall Johnson violated RCW 42.17A.235 and 240 by failing to file a mandatory Summary Full Campaign Contribution and Expenditure report (C-4 report), Post Primary C-4 report due September 10, 2024, covering July 25 to August 31, 2024, disclosing activity undertaken by the Campaign as required by campaigns registered under the “Full Reporting” option.
